I am encouraged to attend regular monthly board meeting, which are held the first Tuesday of each month except October and November. Notice will be given if a change of date is required. I understand that the club is maintained by membership participation at regular scheduled club events and work parties.

I understand that I am expected to abide by and help maintain the following rules:

3. Be very careful on the range so as not to cause accidents.
4. Practice proper etiquette with my bow, my speech and actions.
5. Protect club property and equipment.
6. Unless health forbids, I will try to work a minimum of twenty-five hours (Each family membership) helping at regular scheduled work parties and club shoots. I understand that my family membership can accumulate twenty-five hours of work credit towards my dues for the next year. Annual dues are \$140.00. 25 Work hours can be exchanged to reduce my fee to \$100.00.
7. I will do all in my power to uphold the reputation of Land-O-Lakes Bowmen Inc.
8. I will not operate or allow a motorcycle to be operated beyond the club parking area.
9. I will not ride a horse or allow one to be ridden beyond the club parking lot.
10. I understand that if I violate club rules in a flagrant manner, per club constitution, the board of directors can prefer charges and, if found guilty I can lose my membership and rights to Land-O-Lakes Bowmen Inc.
11. I understand that hunting is allowed on Land-O-Lakes club property in accordance with the By-Laws.
12. I must be present at the board meeting that this application is being considered for approval.
